Trustee Report

The Township will be a vendor at Danny Smith Park .On Saturday, October 28th, 2023 Michelle Bright will pass out information about township services and duties of the Trustee and resources

for food in Monroe County and other help and candy for the kids. About 300 people are expected.

Monroe Fire District has partnered with Centerstone and Overdose Prevention to install Nalax boxes in Monroe Fire Stations. Benton Fire Station has installed a Nalox box at their station. On October 1st a complaint was filed by an individual on the DNR website. DNR advised to contact DNR law enforcement. Mary McInerney thanked the complaint for reporting. The Stepp Cemetery Committee, Ashley and Susan met with Michelle Bright to discuss Baby Lester. Is Baby Lester real or Folklore?

Halloween event at Fire Station from 530 to 830 with treats and Smokey the Bear. Volunteers needed. Sean motioned to approve the Trustees Report and Jake seconded the motion carried.
